Our Vision of Reconciliation

siyeýe is a Musqueam owned company and from our perspective, for reconciliation to truly be effective, it needs to benefit all communities. We recognize our responsibility to help others by sharing our knowledge. We also recognize that we can learn from other cultures. Our company is an example of what reconciliation can look like, Musqueam Nation members and construction experts from Southwest Contracting Ltd. (SWC) recognizing our shared history, sharing crosscultural knowledge, and working together to solve challenges.
